INSTRUCTIONS

In accordance with the provisions of Chapter 110, section 5 of Massachusetts General Law, business certificates shall be in effect for four (4) years from the date of issuance and may be renewed each four (4) years thereafter.

A statement under oath must be filed with the City Clerk upon discontinuing, retiring or withdrawing from such business of partnership.

The filing fee in the City of Springfield is \$50.00, certify copy of the business is an additional \$20.00 should you need it. Please complete the Business Application Form prior to mailing it to the City Clerk's Office or coming in. Any changes to a business certificate is \$40.00.

Copies of such certificates shall be available at the address at which such business is conducted and shall be furnished upon request during regular business hours to any person who has purchased goods or services from such business.

Violations are subject to a fine of not more than three hundred dollars (\$300.00) for each month during which the violation continues.

The filing of a business certificate does not imply compliance with the Zoning Ordinance. Nor is a business certificate a license or permit to conduct business in the City of Springfield.
